**SHAKE WELL BEFORE USE**

- Apply as a dry seed treatment prior to planting.
- Sprinkle SabrEx® onto seed in bag.
- Treat in one bag increments to ensure uniform coating of seed with SabrEx®.
- Shake bag or mix until uniform seed coverage is obtained.
- Plant treated seed directly after SabrEx® seed treatment has been applied.

- Contents may settle. Shake well before use.
- Do not use inoculant after expiry date.
