

TREATMENT	DOSAGE	COMMENT
Row Crops & Vegetables (In-Furrow)	1 - 2ℓ per hectare	 Apply Digital[™] in-furrow at planting. Use a minimum application volume of 30 ℓ of water per hectare. Use lower rates for low seeding rates or seedling stages and higher rates for high seeding rates or full grown stages.
Row Crops & Vegetables (Irrigation or Drenching)	1 to 4 ℓ per hectare	 Apply Digital™ through drip irrigation, pivot or other irrigation systems. Use lower rates for low seeding rates or seeding stages and higher rates for high seeding rates or full grown stages.
Tree crops & Vines (Irriga- tion)	3 to 5 ml per tree (to max volume of 4 l per hectare)	 Apply Digital[™] as a root drench via the irrigation system. For seedlings, apply Digital[™] at plant- ing.
Tree crops & Vines (Irriga- tion)	2 to 4 ℓ per hectare	 Add 100 mℓ Digital[™] to 100 ℓ of unchlorinated water. Apply Digital[™] as a foliar spray.
